The below fees are intended as an estimate for the most common types of UK immigration application and applications for British citizenship; they are not a quote. VAT at a rate of 20 per cent will be applied in addition to our fee. Disbursements (costs related to the matter that are payable to third parties) are also excluded.

<b>Frontier workers</b>	Entry clearance or limited leave to remain as a frontier worker	£250 to £1,000

<b>British citizenship</b>	Naturalisation or registration as a British citizen	£1,000 to £4,000
